1. Letter dated *April 11, 1978* from Dr. Haas to the Chair: Student appeal (anticipated probation). Professor Hayde transmitted the letter to Professor Barnette, Chairman of the Subcommittee on Student Appeals.
2. Letter dated April 20, 1978 from Dean Polowczyk.
Subject: "Questions in Need of Answers". Copies were distributed to the members of the Committee. Items referred to in the letter will be placed on the agenda as new business.

IV. OLD BUSINESS:

1. Student Appeals

Motion (omnibus): To accept the recommendation of the Subcommittee on Student Appeals of the CAS dated April 19, 1978.

Action: Carried 17 - 0 - 0.

IV. OLD BUSINESS (Continued)

2. ESL 01 "Y" Grade Proposal

- A) The "Y" grade is used in the 1st semester of certain 1 year courses at Lehmann College and in the 1st quarter of certain 2-quarters courses at La Guardia Community College.
- B) The significance of CUNY "Y" grade was mentioned.
- C) Amended Motion: The "Y" grade be approved for 2 semesters only (Spring 1978, Summer 1978) for use in ESL 01 for students entering the College in the Spring Semester 1978 or Summer Semester 1978.

Action On Amended Motion

Carried 14 - 0 - 3.

- D) No action taken on Main Motion pending further clarification of significance of "Y" grade.

V. NEW BUSINESS

1. "WU" Grades

Motion: To assign a grade of W to a student who never appears in class.

Discussion followed

Questions raised:

- A) Does the instructor have the prerogative to initiate the W grade?
- B) How many students are we talking about?

2. Retention Concerns

Discussion on the following points:

- A) To implement a procedure for processing "W" grades expeditiously; sending a computer card notifying the instructor that the student has officially withdrawn.


2. Retention Concerns (Continued)

- B) To have a more striking format on the "absence warning" and "debarment" notices, so that student is clearly cognizant of the consequences of WU grade on GPA.
- C) To provide a separate entry, "never attended", in addition to the 3 entries on current WARNING NOTICES.
- D) Status of Temporary Suspension of "Probation ROP": the action of the Council of Presidents has not been approved yet by BHE.
