This proposal calls for the establishment of permanent and ad-hoc subcommittees. To the standing subcommittees already in existence, Prof. Hayde recommended to add subcommittees on Codification Review, Academic Policy Research and Procedures Review.

Note: A quorum now exists.

#### 2. 11-Credit Limitation

Prof. Carl Daley presented the proposal prepared by a subcommittee of CAS to provide support services for students readmitted after having been suspended from the college. Copies of this proposal were distributed for discussion.

MOTION: To abolish the use of S and U as midterm grades.

CARRIED: 9-2-4

### IV NEW BUSINESS

1. To waive academic suspension for certain students. - This proposal was presented by Pro Max Horn. The committee received copies of the background information prepared by the office of Academic Affairs.

MOTION: To readmit students to the college who will be academically suspended at the end of the Fall 78 semester for the purpose of planning with the students for an appropriate educational experience combined with diagnostic testing and career counseling. Such students will be given an opportunity to enroll in appropriate career studies in the Fall of 1979.

Recommendations were made to amend the above motion.


