The Committee notes that the student took both courses prior to the institution of the pre-Nursing sequence requirement and so recommends that they be excluded from the GPA calculation.

V. OLD BUSINESS

1. Proposal to Waive Academic Suspension

Before voting on the motion below, the members of the Committee on Academic Standing made clear that this action is taken only for one semester and will be subject to evaluation. A letter will be sent by the executive secretary of the CAS to the Office of Academic Affairs recommending that a person be made responsible for the implementation of this action and suggesting the name of Dr. Max Horn, who was commissioned to present the proposal to this Committee.

Motion: To readmit students who will be suspended academically at the end of the Fall 1978 semester for the purpose of working with them during the Spring 1979 semester. These students will be offered an appropriate educational experience combined with diagnostic testing and career counseling to determine which students in that group should be given an opportunity to enroll in appropriate Career Studies Institutes in the Fall 1979.


