I. COMMUNICATIONS

1. Communications have been received from Professors Daley, Genova and Read conveying their inability to attend today's meeting.
2. A message has been received from Prof. Quinn saying that she will be late for today's meeting.

II. OLD BUSINESS

Nursing Proposal on Registration.

The Chair informed the Committee about the meeting held with Dean Polowczyk and Prof. Fuller. Prof. Alice P. Fuller distributed some statistical data regarding student grades in Nursing courses and State Board Examinations, and copies of a more detailed proposal. Several amendments were made to the original motion.

MOTION I: To amend the original motion to include Nursing 31 through 38.

ACTION: Carried, 14-0-1.

MOTION II: To start the numbering of the priorities listed in the original motion with number 2, and to add as number 1: "Students who do not fall in the priority categories #2 to #7 below". To change (in priority #6) "failing" to "doing poorly".

To add to #4 and #6 the "NC" grade.  
ACTION: Carried, 14-0-1.

MOTION III: To change, in the introduction of the original motion, "establishes" to "recognizes".

The Chair ruled that the above motion was out of order. The Chair's ruling was challenged, and a motion was made to sustain it.

MOTION: To sustain the rule of the Chair.

ACTION: Carried 8-8-3.

The motion was read as amended:


MOTION: The Committee on Academic Standing at the request of the Department of Nursing, and in accordance with the priorities formulated by that Department in recognition of the imposition of the three hundred students maximum in all Nursing courses effective Fall 1979 semester, hereby establishes, effective Fall 1979 semester only, the following priorities for admitting students to Nursing 31-38:

1. Students who do not fall in the priority categories #2 to #7 below.
2. New Nursing 31-38 students not early registered.
3. Waivers from Admissions and Promotions Committee.
4. Returning students from the old Nursing 11 series with a "C" or better grade in nursing, and students with a "W" or "NC" in Nursing 31-38 who were doing well in the course but withdrew for illness or personal reasons.
5. Returning students who received a "D" in their last nursing course.
6. Students who received a "W" or "NC" in Nursing 31-38 and who were doing poorly at that time, or students who received an "F" in their last nursing course.
7. Suspended students (no suspension imposed).

ACTION: Carried, 14-1-0.

The meeting was adjourned at 3:25 p.m.
