I. MINUTES

III. STUDENT APPEALS

- A. Letter, Prof. D'Andrea to Blanche Hogan, 1/6/71: Informs student that he has closed her grade appeal case due to her not having followed through on the grade-change procedure.
- B. Student appeals considered by the Student Appeals Subcommittee:
 1. MOTION: To accept the Subcommittee's recommendation to change Patricia Payne's grade of "H" in SPH 11, fall 1968, to "J".
PASSED: unanimously.
 2. MOTION: To accept the Subcommittee's recommendation to change Connie Connor's grade of "H" in ENG 1, fall 1963, to "J" and to change her grade of "H" for non-credit course in intermediate algebra, fall 1963, to "J".
PASSED: 17-0-1.

3. MOTION: To change Efrain Garcia's grade of "P" in both GOV 21 and SOC 21, awarded by the CAS, back to the original grades in those courses: "B" in GOV 21 and "C" in SOC 21.
PASSED: unanimously.

Pass/Fail Grade Proposal
