DEFEATED: 3 - 13 - 2.

B. MOTION: To move the primary question.

DEFEATED: 8 - 6 - 3 for lack of a majority in favor of so moving.

Debate ends when the 30 minute limit for discussion of an item of business is not extended.

V. NEW BUSINESS

1. Discussion of a request by the Recording Secretary that a highly detailed motion or one that the mover wishes to be recorded verbatim be submitted in writing to the Recording Secretary by the close of the meeting in which such a motion is introduced.

2. Deadline for resolution of "INC" grades.

NEW BUSINESS (continued)

A. MOTION: That the deadline for resolution of "INC" and "ABS" grades be the end of the semester following the one in which the grade-to-be-resolved was awarded.

- a. MOTION: To divide the question, separating the issues of "INC" and "ABS" grades.
- b. CARRIED: By consent of the assembly.

Further consideration of this matter was postponed until the next regular meeting of the Committee on Academic Standing, pursuant to its rules of procedure.

VI. ADJOURNMENT

The meeting was adjourned at 5:56 p.m.
