1. The awarding of the degree to those students in these categories ("FWE" and "GM") who did not satisfy all other degree requirements is subject to action of the Executive Committee of the Committee on Academic Standing, the names of said students to be reported subsequently to the Committee.

certified by the Librarian or Business Officer -the names of these students to be reported to the Committee on Academic Standing.




