I. CANDIDATES FOR DEGREE, June 1980

1. Motion: To permit the Registrar to approve, in the name of the Committee on Academic Standing, the award of degrees to those students who have Library and Business Office obligations outstanding at this time but which are subsequently satisfied, as certified by the Librarian of Business Officer - the names of these students to be reported to the Committee on Academic Standing.

3. Motion: To award the A.A., A.A.S., or A.S. degrees as applicable to "X" candidates who have completed all the requirements for their respective curricula, including an index of 2.0 or higher.


