
III. NEW BUSINESS

2. Academic Standards and Rate of Progress.
WHEREAS the Committee on Academic Standing is concerned over the potential impact of the new financial regulations being approved by the State Education Department, and WHEREAS the Committee believes it is in the best interest of the institution to have data concerning the effects of such regulations, should they be implemented, so BE IT RESOLVED that the CAS enjoin the Dean of Academic Affairs to immediately conduct a study to determine the impact of the proposed financial regulations of the SED as they would have applied to the Fall 1980 student population had they been effective.
