I. REVIEW OF CODIFICATION

- 1. The Chair made it clear that the only item to be considered at this meeting was the Review of the Codification.
- 2. Incorporation of changes to the Codification made by the CAS subsequent to March, 1973.
 - a. Copies of Excerpts from the Governance Plan had been previously distributed by the Executive Secretary. These copies already included some of the changes made by the CAS.
 - b. The following corrections and additions were made:
 - 1. Paragraph 4.3: Add a third note to read: "Students will be suspended only at the conclusion of the Spring Semester" [May 21, 1980].
 - 2. Paragraph 9.1: Add a.5: "Admission to Nursing Requirements" (as it was approved by the CAS, April 9, 1980).
 - 3. Paragraph 6.3 (added): "Mandatory Change of Curriculum" (as approved by the CAS, May 7, 1980).
 - 4. Paragraph 4.3: Replace Chart for Rate of Progress (as approved by the CAS, June II, 1980).
 - 5. Paragraph 9 (where it may correspond): "Debarment Regulations" (as approved by the CAS, June 11, 1980).

- 6. Paragraph 3: Combine 3. 2, 3. 8 and 3.13, and define clearly "successful" and "unsuccessful" completion of a course.
- 7. Paragraph 4.4.b. needs to be checked by the Registrar.
- 8. Paragraph 8.1.c.: Change "after the beginning of the Semester" to read "after the Change of Program period".
- 9. Paragraph 9.1.b.: The NC grade needs clarification.
- 10. Paragraph 9.1.b.: In paragraphs for ABS and INC grades, change "equivalent" to "converted".
- II. Paragraph 9.3.b.: All references to S and U grades should be removed.
- 12. Page 25: Change * to Note:
- 13. Some grammatical errors and typing mistakes were pointed out by members of the Committee.
- 14. It should be noted that the bottom line of page 15 was missing in the copies distributed.

- 15. The addition of an index, was recommended.
