SUBJECT: Final Report to the Senate of Curriculum Committee
activities for 1980-81

As per your request, I have summarized below the Curriculum Committee actions reported to and approved by the Senate Executive Committee and subsequently by the Senate as a whole at its meeting of 5/28/81.

A) All actions taken from 3/24/81 through 4/28/81, previously reported to the Senate (see attached), were approved in the Executive Committee.

B) Actions taken at the meeting of 5/5/81:

1. Approval of change in course titles for 5 electrical courses: ELC 11, 21, 25, 95 and 98.

C) Actions taken at the meeting of 5/19/81:

1. Approval of a new Liberal Arts Option, International Studies, with two attendant new courses: The Politics of Developing Areas and The Economics of Developing Areas. 18-1-3.

2. Approval of a new course, History of the Ancient World. 21-0-1.

3. Change in existing course ELC 11--to have an additional compensatory hour of instruction with no increase in credit. ELC 01 will no longer be offered. 18-2-2.

4. Change in Pre and corequisites for existing courses ELC 35, 45 and 81; MEC 25, 27, 33 and 41. 18-1-2.

Additionally, please note that at its final meeting for the year, the Committee approved the continuation, as a regular course offering, of the experiment course CWE 33. 13-5-0. This final action was reported to the Senate at its 5/28 meeting and can be ratified at the next Senate meeting.
