B. Returning Students into Nursing

1. Professor J. G. Lourim presented and discussed the Nursing Department's proposal regarding the admittance of returning students to the new curriculum.
  - a. Proposal: Any student returning to Nursing after the inception of the new Nursing Curriculum must start at the beginning of the new program if the courses in her/his original generic program have ended.
  - b. Rationale: Both content and approach of the new curriculum are different from the present program so that it would be impossible to slot students into comparable courses.
2. The matter was referred to the Committee for further study and recommendations.
3. Congratulations were extended to the Nursing Department on the recent success of their students in the June, 1982 State Boards Examination.


MOTION: To sustain the congratulations as a motion.
