- A. The CAS Subcommittee on Graduation will meet Tuesday, October 18, 1983, at noon, in the Registrar's Office, Room 14.


V. NEW BUSINESS

SUBJECT: Annual Report

The Committee on Academic Standing did not complete its regular business for the Academic Year 1982-1983 until after the last Senate meeting for that year and that is the reason for the delay in submitting this final report.
