#### IV. OLD BUSINESS

## A. Grading Symbols

Professor O'Sullivan reported that new standards for retention were still being discussed. However, because of the ambiguity in the use of the "NC" grade, the Subcommittee proposed:

Motion: To substitute the grade of "W" for "NC" and abolish the use of the "NC" grade at Bronx Community College. In cases where the "NC" was formerly used, (for withdrawal from the College through the tenth week of the semester) the grade of "W" be assigned.

Action: 14-0-1

#### B. Withdrawals

The Committee was informed that Dean Polowczyk has delegated his authority to grant students permission to withdraw after the tenth week of classes to the Dean of Students.

The Chairman announced that in order to expedite the withdrawal process, the Dean of Students be granted permission to hear all cases for withdrawal after the tenth week; however, as stated in the CAS Codifications, Section 10, the CAS may adjudicate all questions involving evaluations of W, WU, R, and NC.

# C. Minimum "C" Grade in Major Area

Professor Shopkow distributed a memorandum (Attachment 2) from Professor Hirshfield, Chairperson of Buiness and Commerce, which proposed that "students who receive lower than a "C" grade in DAT 30 (Introduction to Computer Systems) be required to repeat the course."

Discussion revealed that the possibilities of job placement for students who do not achieve a grade of "C" or better are virtually non-existent according to Professor Shopkow.

Motion: A minimum "C" grade for the first data processing course in the Business and Commerce Department be established with the permission to repeat the course only once. This applies only to majors in the data processing curriculum.

## D. Dean's List Requirements

Mr. Lewis informed the Committee that a comprehensive review of students' averages for Dean's List eligibility (as stipulated in the CAS Codifications, Section 5.1 of 12 credits) was being conducted by Computer Center personnel and will be discussed at a future meeting.
