B. Title IV Rate of Progress Regulations were discussed at length by the Committee. Prof. Barnette distributed copies of a chart showing how full time equivalent year status (FTEY) would be determined. Prof. Erdsneker informed the Committee that 1200 students were put on probation as of June, 1984; the new standards proposed would have put 1811 students on probation. The Committee was also informed that a student will most likely be suspended because of a low GPA, not because of the new ROP regulation.
