I. MINUTES

B. Title IV Regulations were again discussed by the Committee. Prof. Barnette presented an informative chart explaining formulae used to determine a student's standing relative to the new ROP regulations. (Chart appended) The Committee expressed appreciation to Prof. Barnette for her work in this area.

V. NEW BUSINESS

A. The Chairman announced that Mr. Lewis had completed his check-out for the August graduation, and that the Graduation Meeting would take place in the present meeting instead of Oct. 31 as formerly stated. Following are the Committee's actions for the August graduation:

ACTION: 17-0-0


The Committee thanked Mr. Lewis for his work on the list of students for the August graduation.
