I. COMMITTEE REPORTS:

A. Executive Committee:

B. Governance and Elections:

Dr. Lieblich, Chairman of the Committee reported the following:

1. The committee is studying reform of student election procedures. It is awaiting information from the University Student Senate of CUNY on uniform procedures and dates.
2. An ad hoc editorial committee, convened by Dean Miranda at the request of Prof. Tyson, is considering rhetorical revisions to the SGA Constitution. Dr. Witlieb of the English Department has joined this committee.
3. University Faculty Senate ballots are in duplicating for January 4, 1985. Nominations are due February 4, 1985.
4. The Science-Mathematics-Technology Division representatives to the Committee on Instruction and Professional Development are temporarily replaced for this semester. Setting of meeting times is the prerogative of the committee.
5. Amendments to the SGA Constitution are tabled pending revision of the present Constitution.

D. Curriculum:

Prof. Ehrenpreis made reference to the written report on curriculum and course revisions acted upon in the period September 25 - November 27, 1984, submitted to the Senate by Dr. Ryan, Chairman of the Committee. The major curriculum actions, said Prof. Ehrenpreis, were the approval of the Nursing Program revisions and revision of the Liberal Arts Transfer Curriculum.

F. Instruction and Professional Development:

Prof. Pomerantz, Chairman of the Committee, reported the following:

1. Divisional representatives supply the committee with a variety of strengths. Their full commitment is needed, as interruptions of attendance slow the work of the committee. The scheduling of programs must allow for this. Chairpersons should attempt to make individual faculty program modifications to permit elected representatives to serve.
2. The committee is revising the student evaluation of instruction form to produce a more scientific instrument. It is intended to be used in the Fall of 1985. The current form will remain in use until then.
3. The committee plans to present workshops and panel discussions on the instructional activities at the College.

G. Community Relations & Special Events:

The committee is in the process of being reactivated before its elimination is considered by the Senate.

## II. REPORT FROM THE UNIVERSITY FACULTY SENATE

Dr. Galub reported:

1. Chancellor Murphy has submitted his budget to Albany.
2. The Board of Regents has authorized the Trustees of CUNY to award the degree of M.D.
3. Vice Chancellor Bloom stated that early retirement will probably not be extended to community college faculty.
4. The University is screening its day-care employees.
5. A resolution on the allocation of lines to replace retirees is being considered.
6. A resolution is pending on the indemnification of committee members sued for their part in personnel actions.
