MOTION: To approve the Minutes of October 30, 1985 as read.

MOTION: To approve the recommendations dated November 6, 1985 from the Subcommittee on Student Appeals.

IV. Old Business

The Proposed Change of the Codification of Academic Regulations Relating to Grade Point Average Calculation.

This being the third reading of the proposal, the following action was taken:

MOTION: To approve paragraph one of the Proposed Changes to the Codification of Academic Regulations dated October 16, 1985 relative to changing "Cumulative Credits Taken" to read "Cumulative Indexable Credits", (omitting the word "taken").

ACTION: Approved, 15-0-0

MOTION: To amend paragraph two of the above proposal to read as follows:

2. The process of classifying students for matriculation and retention be amended so that students will be evaluated on the "C" line until 24 "X" credits are accumulated, at which time determination will be on the "X" line degree credits only.

Since this is a major change to the proposal, it will be read again at the meeting on December 11, 1985, and voted on in February 1986.

Departmental representatives reporting that these proposed changes were discussed at departmental meetings included Business, Communication Arts and Science, Nursing, Secretarial Studies, and Student Development. All of these departments approved of the proposed changes, with the exception of Student Development who proposed the amendment to paragraph two as presented above.

The Registrar stated that he will attempt to implement the changes as soon as all necessary approvals are secured.

VI. Dates of the Next Meeting and Adjournment.


