The Proposed change of the Codification of Academic Regulations relating to Grade Point Average Calculation.

This being the second reading of the proposal, no action was taken:

MOTION: To amend paragraph two of the above proposal to read as follows:

2. The process of classifying students for matriculation and retention be amended so that students will be evaluated on the "C" line until 24 "X" credits are accumulated, at which time determination will be on the "X" line degree credits only.

#### V. New Business

The following members were elected to a Executive Subcommittee, to consider candidates for graduation in January, 1986: Profs. J. Hayde, R. Barnette, P. Read, J. Skurdenis, H. Erdsneker, and Ms. Cheryl Bethea.

Prof. Greenfield stated that according to the Codification, a student must complete at least 12 degree credits with a scholastic index of 3.00 or higher. He questioned the Dean's list program 12/5/85, which stated that at least 15 degree credits must be completed.
