Discussion continued on the present disparity between 6 months suspension based on GPA and 1 year suspension based on POP. Prof. Strauss attended the meeting to clarify the rules of financial aid as they apply to suspended students.

MOTION: To change the Codification of Academic Regulations to increase the length of suspension for GPA to 1 year to conform to present regulations concerning POP students

C. Dean's List

Prof. Hayde distributed copies of his suggested changes regarding Dean's List Regulations.

PROCEDURAL MOTION: To waive the rules of the Committee requiring no action until the third meeting following initial presentation of a proposal.

ACTION: Approved 17-0-0

MOTION: That the CAS codification be changed to read as follows for the regulations presently bearing the designation listed below.

5. DEAN'S LIST AND AWARDS

5.1 Students shall be eligible for inclusion on the Dean's list when they have completed a minimum of 12 college-level (i.e. X line credits) with a CUMULATIVE GRADE POINT AVERAGE (GPA) of 3.00 or higher.

5.2 Students will be evaluated for inclusion on the Dean's list upon successful completion of:

- 12-20 college-level courses (X line)
- 21-40 college-level courses (X line)
- 41-60 college-level courses (X line)
- 61 or more college level courses (X line)

5.3 No student shall be included on the Dean's list more than once for each of the 4 credit bands described in paragraph 5.2. As a consequence of this rule no student may be included on the Dean's list more than four (4) times during his/her stay at the College.

ACTION: Approved 17-0-0
