V. NEW BUSINESS

1. Index Chart for Readmission

Prof. Barnette distributed the following Guidelines for Appeal of Status due to suspension:

A student returning from suspension will be readmitted if the student has:

- 0 - 11.5 Degree Credits - No minimum GPA
- 12 - 23.5 Degree Credits with an  $\bar{X}$  Index greater than or equal to 0.85.
- 24 - 37.5 Degree Credits with an  $\bar{X}$  Index greater than or equal to 1.40.
- 38 - 51.5 Degree Credits with an  $\bar{X}$  Index greater than or equal to 1.65.
- 52 - 63.5 Degree Credits with an  $\bar{X}$  Index greater than or equal to 1.75.
- 64 - 73.5 Degree Credits with an  $\bar{X}$  Index greater than or equal to 1.80.
- 74+ Degree Credits with an  $\bar{X}$  Index greater than or equal to 1.90.


2. Pursuit of Progress Table
