I. Minutes

V. "F" Grade Proposal

The Committee considered Harvey Erdsneker's response, addressed to President Roscoe C. Brown, Jr., to the Board of Trustees' "F" grade policy, in a memo dated October 29, 1990 (copy attached).

VI. Nursing Department

Motion: To rescind the Committee's approval of the following proposal made by the Nursing Department (3/14/90):

8.2. Grading requirements in specific curricula.

8.2.1 Nursing.

The minimum acceptable passing grade in all nursing courses (Nur 41 - Nur 48) is C+.
(3/14/90 : 10-0-2)

Nursing students who fail to achieve a minimum of C+ in both Nur 41 and Nur 42 will not be permitted to repeat either course or continue in the nursing curriculum. (3/14/90 : 10-0-2)

Grades of C, D+, D or F in Nursing Technology courses (Nur 43 and higher) must be repeated if the student wishes to receive a degree in Nursing. Grades may be repeated, subject to the following conditions:

- The course must be repeated and completed before the next higher level course may be taken.
- Both grades received in the same course will be used to calculate the student's cumulative Grade Point Average (GPA).
- The credit for a repeated course may be applied only once toward graduation.
- A student may repeat such a course only once.


VII. Subcommittee on Student Appeals
