I. Minutes

- A. Motion: To approve the minutes of June 18, 1991. Approved 10-0-2.
- B. The minutes of the July 25, 1991 Executive Committee meeting were presented to the Committee.

Prof. Hayde presented his annual CAS report (1990-1991) to the Senate for Committee approval. General approval was noted.

III. Student Appeals

- A. Suspension appeals were considered during the summer. There are appeals pending that require action.

V. New Business

Committee Elections:

- A. Prof. J. Hayde was unanimously reelected chair of the Committee.
- B. Prof. P. Read was unanimously reelected recording secretary.

VI. Graduation Business

A. The following *pro forma* motions were made:

- 1. To empower the Registrar to award the degree to all students who have the credit requirements for their

respective degrees with a cumulative index of 2.0 or higher.

2. "FWE" and "GM": To permit the Registrar to approve, in the name of the CAS, the awarding of degrees to those students whose records are not complete at this time as a result of registration at other colleges from which official transcripts have not been received to date, or who are missing grades. Such approval is to be granted upon receipt of official transcripts (or grades), assuming all other requirements for the degree have been met. The awarding of the degree to those students in this category (FWE) who did not satisfy all other degree requirements is subject to action of the Executive committee of the CAS. (Names to be reported subsequently to CAS.)
3. "L" and "B": To permit the Registrar to approve, in the name of the CAS, the awarding of degrees to those students who have Library and Business Office obligations outstanding at this time but are subsequently certified as "clear" by the Librarian or Business Officer. (Names to be reported subsequently to CAS.)

Motions 1, 2, and 3 approved unanimously.

4. Motion: To grant the A.A., A.S., and A.A.S. degrees to all students whose names appear on the list the Registrar presented to the Committee. Approved unanimously.
