**I. Minutes**

Motion: To approve the minutes of November 3, 1993. Approved 12-0-1.

**III. Student Appeals**

- A. Omnibus motion: To sustain the recommendations of the Subcommittee on Student Appeals in its minutes of November 10, 1993. Approved unanimously.
- B. Omnibus motion: To sustain the recommendations of the Subcommittee on Student Appeals in three cases tabled previously (cited in the Committee's minutes of November 3, 1993). Approved 14-0-1.
- B. In response to a student inquiry, the Committee is asking the Executive Secretary of the CAS to write a letter notifying the student that admission to Special Programs is not within the purview of the Committee.

**V. Old Business**

**A. Grading in RAD TECH**

Motion: To accept the following amended priority list as criteria for determining readmission to the Radiologic Technology Curriculum and Radiologic Technology courses (criteria to be included in the CAS Codification). (Amended part of motion is in italics):

- . Students with a W in a *Radiologic Technology* course during the *previous semester*, who were doing well in the Radiologic Technology Program, but withdrew because of illness or personal reasons
- . Students returning after an absence of one or more semesters from the Radiologic Technology Program with a C+ or better in each Radiologic Technology course and B or better in each Clinical

Education course

. Students who did not achieve at least a C+ in any one Radiologic Technology course (or Nuclear Medicine Technology 84) will be placed on a waiting list. Students will be able to re-register according to the following priorities:

1. Those who have been on a waiting list for at least one semester

2. Those who have been on the waiting list for less than one semester

. Students who received grades of less than C+ in more than one Radiologic Technology course (including NMT 84) or less than B in any one Clinical Education Course (CLE) will not be eligible for re-admission to this program.

B. **Criteria for Admission into Clinical Nursing Sequence**

Motion: To accept the following amended criteria for admission into the clinical nursing sequence. (Amended part of motion is in italics):

To be eligible for admission into the clinical nursing sequence, applicants must achieve:

(1) at least a "C+" grade in both Biology 23 and Pharmacology 10, (2) a pre-nursing sequence average of 2.5, and (3) a minimum composite percentile score of 40 on the National League for Nursing Pre-Admission Examination R.N. test (*PAX-RN*).\*

or

(1) a pre-nursing sequence average of 3.0 and (2) a minimum composite percentile score of 40 on the National League for Nursing Pre-Admission R.N. Test (*PAX-RN*).\*

These changes will apply to students (1) with student numbers beginning 294 or later; (2) who transfer to the pre-nursing/nursing curriculum after 1/94; (3) who return to the College via reinstatement after an absence of one or more semesters and have not achieved placement on the nursing waiting list.

*\*The PAX-RN may be taken up to two times.*
