I. Minutes

IV. New Business

A. The Nursing Department representative notified the Committee that a proposal from the Department will be submitted at the next CAS meeting.

B. Candidates for graduation--January, 1996:

1. FWE and GM Motion: To permit the Registrar to award the appropriate degree of Associate in Arts, Associate in Sciences, Associate in Applied Sciences or the Certificate, in the name of the Committee, to those students who are indicated on the Candidate listing as Finishing Work Elsewhere (FWE) and whose grades have not yet arrived at the College, and to those students indicated as Grades Missing (GM), when all of the grades become available and the students are found to have completed all of the requirements for the degree, have completed a minimum of 64 credits and have an index of at least 2.00. These students' names to be reported back to the CAS. Approved unanimously.

2. L&B Motion: To permit the Registrar to award the appropriate degree of Associate in Arts, Associate in Sciences, Associate in Applied Sciences or the Certificate, in the name of the Committee, to those students who are indicated on the Candidate listing as having a Library Hold (L) or a Bursar's Office Hold (B), when the hold is removed by the appropriate office and the students are found to have completed all the requirements for the degree, have completed a minimum of 64 credits and have an index of at least 2.00. These students' names to be reported back to the CAS. Approved unanimously.

3. Graduation Motion: To permit the Registrar to award the appropriate degree of Associate in Arts, Associate in Sciences, Associate in Applied Sciences or the Certificate, in the name of the Committee, to those students who are indicated on the Candidate listing as ✓, who have completed all of the requirements for the curriculum, have completed a minimum of 64 credits and have an index of at least 2.00. These students' names to reported back to the CAS. Approved unanimously.

4. Doubtful cases:

a. Motion: To award the degree in the case of # 9939269. Approved 10-0-1.

b. Motion: To award the degree in the case of # 9906039. Approved unanimously.

c. Motion: To award the degree in the case of #2944156. Approved unanimously.
