#### RP called the meeting to order at 2:02pm

- 1- February and March 2018 minutes approved with no amendments.
- 2- Nora OLS needs to know how to send us money for funding the institute. Geri says they can write a check in the amount (\$500).
- 3- LACUNY Institute
  - a. We need to increase calls to register for the event only 58 people registered so far. Instead of a Keynote speaker, there will be 3 panelists.
  - Ryan received quotes for general liability insurance for LACUNY. Diversified Risk Solutions quoted \$131 to insure the Institute. We will go with this company.
    Insureanonprofit quoted \$191; Gab Associates Insurance Brokerage quoted \$177.
  - c. Code of Conduct working group- we may not need to change the LACUNY by-laws. Instead, the executive council can vote to approve and implement the code of conduct at the first fall meeting in 2018 and keep it live on the organization website. Nora suggest we send it out to all members and vote at the Spring meeting.
