3. Minutes. Approval of the minutes of April 29 was postponed until next meeting.

 - B. Letter from Department of Social Sciences requesting that the International Studies Option be placed on the agenda of the first meeting of the Curriculum Committee in September, considering the committee's heavy agenda and the fact that it will take some time to respond to the Committee's questions, received and noted.
5. Old Business -- Action Possible.
 - A. Paralegal Studies Curriculum (Dept. of Bus. and Comm.).
B. Witlieb asked that, in the Curriculum pattern, the description of English 13 be changed to Fundamentals of Written Composition, and that the second English offering be amended to read "English 14, 15, 16 or 18" in place of Eng. 18. This was accepted as a friendly amendment by B. Reshen, with the option to change this decision if it caused any problems in the acceptance of these courses at higher levels.
A motion was accepted to approve the Para-Legal Studies package, as amended. The vote was:

 - B. Avionics Curriculum (Elec. and Mech. Eng. Tech. Dept.).
