3. Minutes.

The Minutes of May 27, 1980 were approved unanimously, subject to possible clarification of the math requirement for the technology curricula. ✓
4. Correspondence.
 - A. The Chair read the letter he sent (per the Committee's request - May 27, 1980) to Professor Henry Frisz, concerning the Automotive Certificate Curricula, and Professor Frisz' response (attached).
 - B. The Chair distributed the collected Departmental Reports Re Requirements for Entry Level Courses.
5. Election of Chair.

Nominations were: Dr. James Ryan, Dr. Gerald Lieblich

6. Motion. To select secretaries for Curriculum Committee meetings on a random basis, as in a tontine.

8. Senate Report.

At its September 18 meeting, the Senate approved the remainder of the Spring '80 actions except the prerequisite changes for Geography 10.

9. Religion Curriculum.
After a Letter of Intent will be sent to the Board of Trustees, the Religious Curriculum will be presented to the Curriculum Committee.
10. Paralegal Studies Package (Course and Certificate).
In this first week of discussion, the representative of the Business and Commerce Department made a presentation and received questions.
11. Automotive Certificate Curricula.
Professor Ryan will send a letter to Professor Frisz requesting by November 1, 1980 the evaluation report of the Automotive Certificate Curricula and the plan for the second tier of courses.
12. Proposal Deadline.
The deadline for receipt of proposals and other course changes, additions and deletions will be April 28, 1981.
13. Remediation Flags and Registration.
Concern was expressed that the Office of Academic Affairs had not followed Curriculum Committee guidelines when it set up Remedial Flags for this semester's registration. The Dean's representative stated that the sophistication of the computer program did not permit English or ... to be flagged, so English and ... was used.
14. The next meeting will be held on Tuesday, October 7 at 2:15 p.m.
15. The meeting was adjourned at 3:50 p.m.
