1. Call to Order. The meeting was called to order by the Chairperson, Prof. J. Ryan.
2. Attendance.

3. Minutes. The minutes of October 28th were approved with the following corrections on page 13, item 5:
 - A. Spelling correction of Ms. Gail Hauss.
 - B. Spelling Correction of last word in said item to weeks.
4. Correspondence.
 - A. Prof. O. Rodzianko, in a communication directed to Prof. J. D'Andrea, Dean C. Polowczyk and Dr. J. Ryan, Chairman, Curriculum Committee, clarifies item 4C of the October 28th minutes by commending Prof. D'Andrea on his careful reading of the Chancellor's Report and confirming that in the Fourth Semester of the new Electrical Technology Curriculum the elective listed should have read "Liberal Arts Elective" instead of "Social Science Elective". Prof. Rodzianko further states that the footnote which refers to this elective is correct and that steps will be taken immediately to make this correction.
 - B. Communication from Dean Polowczyk regarding registration procedures and an attached revised flag list for RR courses. This new item is dated November 18th.

Substitute Motion: Dr. B. Witlieb proposed and so moved that the ammended motion be severed to read as follows:

- A. Motion to reaffirm the June, 1979 list of RR courses as accepted procedure.
