2. Attendance.

3. Minutes. The minutes of Nov. 18 were approved with the following corrections:

  - B. Page 18, item 6, paragraph 4: substitute motion "A" should read: "To reaffirm the College-wide corequisites as established in June, 1979 by the Curriculum Committee."

5. Prof. J. Ryan answered questions regarding the change of prerequisites for GEO 10, Human Geography (History Dept.), and made the following motion:


Motion: That GEO 10, Human Geography, be listed as having a minimum corequisite of ENG 01 or RDL 01.
