5. New Course Proposal: Philosophy of Religion (Social Sciences)

J. Ryan answered questions regarding the course. A motion to approve the course was passed : YES 20, NO 1, ABSTAIN 1.

Course Description: Religion, a human phenomenon, is the central concern of this introductory philosophy course. The central core of religion -- the numinous experience -- is defined and analyzed. Key questions to be explored include: conceptualization of the divine; supposed proofs of God's existence; doubt; and various religious attitudes toward the self, nature, and the meaning of life. 3 rec. 3 cr. Prerequisites: Introduction to Religion or PHL 11.

6. New Course Proposal: Religion and Society (Social Sciences).

A. Galub answered questions concerning the course. Further consideration was held over until the next meeting in order to permit Dr. Morrill to appear and answer additional questions.
7. Subcommittee on Continuing Education.

Dr. Galub was elected to the Subcommittee to replace Dr. Fahey.
8. New Course Proposal: Nutrition in Physical and Emotional Disorders (Nursing) (No action possible).

10. New Course Proposal: Introduction to Tai Chi Chuan (Health and Physical Education) (No action possible).


M. Wenzel distributed copies of the proposal.
