Course Description:

Religion and Society: The course explores the social origins and phenomena of religion, including its meaning for the individual and what functions it serves for the society. It examines religion and religious ideology in American society and other societies historically and cross-culturally, and current religious movements.

Prerequisites: SOC 11 or Introduction to Religion

C. Course Description

Nutrition in Physical and Emotional Disorders:

A basic course in therapeutic nutrition that focuses on major health problems in Western society and the influence of diet on the causes and cures. Traditional and controversial approaches will be presented. Nursing care in selected situations will be emphasized.

Prerequisites: NUR 32, 33

6. New Liberal Arts Option: International Studies (Social Sciences). Prof. A. Galub answered questions. (No action possible at this time).


7. Change in existing course "ELC II". Prof. P. Berger answered questions. (No action possible at this time).

New Corequisites: RDL 01 and Eng-01. An amendment was presented: To adopt the proposed changes on an experimental basis by "block-programming" a selected number of students in RDL 01, Eng-01 and one of the Art and Music courses.
The amendment is under discussion.

10. Prof. Weiman distributed materials: ^{W/E}CEW (Business and Commerce). Prof. Hirshfield requested that the curriculum committee consider a proposed change of status of ^{CWE}CEW 33 from an experimental course to a permanent one.
11. Changes in existing courses and curriculum pattern: ELC 35, 45 and 81 (Dept. of Mech. and Elect. Tech.)
Prof. P. Berger was present to answer questions.
