1. **CALL TO ORDER:** Chairperson R. Bass called the meeting to order at 12:25 p.m.
2. **APPROVAL OF THE AGENDA :**The agenda was approved.
3. **APPROVAL OF MINUTES:** The minutes of May 21, 1998 was approved with corrections.
4. **ELECTION OF VICE CHAIR:** Elliot Cox was nominated. He is the new Vice Chairperson.
5. **PRESIDENT'S REPORT:** Dr. Williams reported that on October 16<sup>th</sup> we will have a visit from middle states. There are eleven new hires and 17 new positions, 21 presidential grants funded through presidential program. A Member of CUNY Task Force visited on Tuesday. Institutional Planning and Budgeting process is moving forward and the May 26<sup>th</sup> Board resolution is still in litigation. There is no news on the Chancellor search. She announced that the Vice President for Student Affairs search extended until end of month we have two names, and we are looking for three additional people. She announced Dr. Misick's new position, Acting Dean of Student Affairs. Dr. Williams announced that Vice Chancellor, Pacelli, visited BCC and shared creative ideas and lended leads for us to follow.

## **6. ANNOUNCEMENTS:**

Chairperson - Dr. Bass announced that the Faculty Council will meet October 8<sup>th</sup>. Dr. Daley resigned from the college Senate. Dr. Berger needs time in the October Senate meeting. The Draft will be ready for groups to look over on November 11<sup>th</sup>. Dr. Williams is hosting two forums in Nichols Hall to finalize draft five.

Vice President - Dr. Keizs announced the APP Document for retention, and two new curriculums 1) Environmental Tech and 2) FDA Food and Warehouse. She also announced the September, October, and November orientation for faculty. The Director of Academic Advisement is close to being selected.

Vice President Coleman announced that there is a new Administration Superintendent, Manny Ballen. There is a new traffic pattern around quadrangle.

The financial condition is that community colleges received monies, but not for programs. The money for the contract has to come from the colleges cut backs.

Dr. Misick announced that the Student Government will be installed September 24<sup>th</sup> at 5:00 p.m. and the search for Director of Student Center is on.

Dean Kish reported registration is officially over Friday, September 20<sup>th</sup>, and this is end of refund liability period.

Dean Sanchez reported we have a contract!

**b) Curriculum** : Met on Tuesday - Dr. Ryan is Chairperson


**c) Deans** - No report
