- 4. Announcements from President Williams: A. A letter of affirmation was received from Middle States. The next self-study, 2008-2009, will address Math skills passing rates, non-traditional class offerings and student satisfaction surveys. B. Capital needs were presented to the City council in November. The council has been invited to visit BCC on December 14, 2004. C. The president's Holiday Party is scheduled for December 13 at Roscoe Brown, 3 5 p.m
- 5. Announcements for V.P. Keizs: A. Chairpersons have received a letter from the Chancellor expressing the need to increase evening and weekend course offerings. B. BCC has been asked to develop six working groups in the following areas: I) Instructional Technology improvement (already launched; II) discussion of student accumulation of 45 credits without finishing remediation (already launched); III) a "Teacher's Academy"; IV) Student Retention; V) Articulation and Transfer; and VI) Enrollment Management.

12.6 Multiple Degrees. (Changes approved 17-0-0 on 12/3/97)

12.6.1 Requirements for multiple degrees

A student may earn only one Associate in Arts (AA) degree. However, a student may earn multiple Associate in Science (AS) degrees, or multiple Associate in Applied Science (AAS) degrees, or an AA degree and multiple AS degrees in areas in which the degrees are distinct and different. Course requirements for the second degree are those curriculum requirements in effect when application for the second degree is approved.

12.6.2 Application for an additional degree.

A student must obtain an application for a second degree from the Registrar's office. The application must then be approved by the curriculum coordinator of the new curriculum and by the Vice President of Academic Affairs.

12.6.3 Course credits for additional degrees.

Credits that may be counted twice (i.e. both curricula) are courses in the Core Requirements and in the Required Areas of Study. Grades for credits counted twice will also be computed in the Grade Point Average (GPA) for the second degree.

12.6.4 Minimum credit requirements for additional degrees

An applicant for a second degree must complete a minimum of fifteen (15) additional credits for the second degree. Nine (9) of the fifteen (15) additional credits must be taken at BCC, except in those curricula in which all specialization courses are required to be completed at BCC.

12.6.5 Advance standing limitations on multiple degrees

For each multiple degree, a student may receive a maximum of thirty (30) advance standing/exemption credits.

12.6.6 Matriculation status for students attempting multiple degrees

A student who has been awarded a degree by the College may continue to attend under non-degree regulations.

After the application for a second degree has been approved, the Registrar will determine the matriculation status based on the student's GPA.

12.6 Multiple Degrees.

12.6.1 Requirements for multiple degrees

A student may earn only one Associate in Arts (AA) degree. However, a student may earn multiple Associate in Science (AS) degrees, or multiple Associate in Applied Science (AAS) degrees, or an AA degree and multiple AS degrees in areas in which the degrees are distinct and different. Course requirements for the second degree are those curriculum requirements in effect when application for the second degree is approved.

12.6.2 Application for an additional degree.

A student must obtain an application for a second degree from the Registrar's office. The application must then be approved by the curriculum coordinator of the new curriculum who will document which courses from the first degree will be applied to the second degree and which courses still need to be taken for the second degree, and by the Vice President of Academic Affairs.

12.6.3 Course credits for additional degrees.

Credits that may be counted twice (i.e. both curricula) are courses in the Core Requirements and in the Required Areas of Study. Grades for all of the courses a student has taken at Bronx Community College for credits counted twice-will also-be computed in the Grade Point Average (GPA) for the second degree. In addition, no grade used for the first degree will be changed under the Statute of Limitations or F Grade Policy. Only the additional courses that have been listed by the Curriculum Coordinator can be changed using these policies.

12.6.4 Minimum credit requirements for additional degrees

An applicant for a second degree must complete a minimum of fifteen (15) additional credits for the second degree. Nine (9) fo the At least fifteen (15) of the additional credits must be taken at BCC, except in those curricula in which all specialization courses are required to be completed at BCC.

12.6.5 Advance standing limitations on multiple degrees

For each multiple degree, a A student may receive a maximum of thirty (30) advance standing/exemption credits for a particular degree during his/her tenure at BCC. If a student is required to take more than 15 credits to complete a multiple degree, then that student may transfer in additional credits as long as the total number of advanced standing credits counted toward the second degree does not exceed 30 credits.

12.6.6 Matriculation status for students attempting multiple degrees

A student who has been awarded a degree by the College may continue to attend under non-degree regulations. After the application for a second degree has been approved, the Registrar will determine the matriculation status based on the student's GPA.

Current Policy (Passed by the Senate in Spring 2004):

4.2.2 Admission to Nursing Curriculum

To be eligible for admission to the nursing program, students must achieve at least a 2.3 (C+) index in the pre-nursing sequence of courses and

- A. Pre-nursing students (047) are allowed <u>two</u> attempts to achieve a C+ in BIO 23 (Human Anatomy and Physiology I) and Pharmacology 10. A minimum grade of 'C+' or better in these courses is a requirement for admission into the Nursing Program. (A grade of 'W' and or 'WA' will not be counted as an attempt.
- B. Take the National League for Nursing Pre-Admission Examination (PAX-RN) advisement tool. The results on the PAX-RN will be used to advise students. Upon reviewing PAX-RN results, students may be advised of supportive course work to potentially increase chances for success in the program. RN Fast Track and RN Pathway Admission students are exempt from taking the PAX-RN.
- C. Have completed all required remediation.

Addition to Section 4.2.2:

4.2.2 Admission to Nursing Curriculum

To be eligible for admission to the nursing program, students must achieve at least a 2.3 (C+) index in the pre-nursing sequence of courses and

- A. Pre-nursing students (047) are allowed <u>two</u> attempts to achieve a C+ in BIO 23 (Human Anatomy and Physiology I) and Pharmacology 10 (Pharmacology Computations). A minimum grade of 'C+' or better in these courses is a requirement for admission into the Nursing Program. (A grade of 'W' and or 'WA' will not be counted as an attempt.) A student who withdraws from PHM 10 with a grade average below the minimum grade average required for a C+ (77.0) will be considered failing the course and will receive a "WF" grade. A "WF" counts in the G.P.A. as a failing grade.
- B. Take the National League for Nursing Pre-Admission Examination (PAX-RN) advisement tool. The results on the PAX-RN will be used to advise students. Upon reviewing PAX-RN results, students may be advised of supportive course work to potentially increase chances for success in the program. RN Fast Track and RN Pathway Admission students are exempt from taking the PAX-RN.
- C. Have completed all required remediation.
