A. Chairperson, Vice-Chairperson, and Faculty Council Chairperson's Report:

R. Bass explained that the motion made by A. McInerney and voted on by the body at the 12/6/07 Senate meeting should have been presented at two meetings before ratification (and is now moot because a tuition increase was not, after all, presented in the budget);

P. Cunningham announced that at the 2/29/08 Martin Luther King Dinner, a Legacy Award will be given out as well as a new award, "Starting the Legacy Award," for outstanding students;

P. Read announced the 2/28/08 Faculty Council agenda and thanked M. Holden, Public Safety for opening the Osborne Place gate to facility automobile traffic

B. Senior Vice-Presidents and Deans Report:

G. Sanchez (on behalf of C. Williams) thanked BCC students, faculty, and staff who recently met with members of the Black and Puerto Rican Caucus in Albany, NY; he also thanked participants of the World Congress (2/18-20); he noted that the IEVS has classroom applications; he encouraged members of the body to participate in Middle States Activities

M. Coleman reported on the proposed decrease, by \$50 per FTE, of CUNY community colleges' operational budgets by the State of New York tuition and proposed budget cuts by New York City; she requested that faculty and staff contact Public Safety to volunteer to be trained for defibrillator operation; in addition she asked that all members of the community register for CUNY Alert; questions were raised about the sinkhole: repair is to begin this semester and should be completed by Fall 2008

B. Gantt reported on enrollment trends and changes in the late registration process; he announced the CUNY Summer in the City program and CUNY's recommended changes to identifying students attempting to transfer to CUNY Nursing programs

C. Savage announced the BCC Gala, 4/16/08, and announced the Faculty Scholarship Awards for travel reimbursement
