**Item 4: Proposed Amendments to Section I(A) of the BCC Governance Plan**

After discussion, Motion to accept Item 4; Amendment to Item 4 offered by A. McInerney: at (iv), strike long passage such that (iv) reads: "At large representatives: For any at large seat on the Senate or other committee, alternates shall be elected for each such at large delegation (in a number hereinafter provided). After seating, such alternate shall be seated for the entirety of the meeting, without regard to the late arrival of any member. Such alternate shall be counted for quorum and may vote on any matter."
