1. **Call to order** 12:25 p.m., A. McInerney
2. **Greetings** A. McInerney announced that voting would take place via paper ballot. Electronic balloting should return in November.
3. **Agenda** Approved by unanimous voice vote.
4. **Minutes** Accepted by unanimous voice vote.

**5. Election of Two Tenured Full Professors to the Academic Review Committee**

A. McInerney explained that 30 votes are needed for election.

M. Pita was elected at the September meeting. M. Garrido declined her nomination after the September meeting. M. Bates and D. Morris were elected by the College Personnel and Budget Committee in September.  
\* J. Malinsky's candidacy removed by majority voice vote after first ballot (L. Broughton and S. Davis – **No**; A. Wolf – **Abstention**). \*\* A. Finkelstein's candidacy removed after second ballot by unanimous voice vote.

Motion to cast vote for the candidate with the higher number of votes passed: **35—YES, 6—NO, 2—ABSTENTION.**

Motion to elect M. Psarelli to Academic Review Committee passed unanimously by voice vote.

**6. Referendum Items—passed with a positive vote of the Faculty with a quorum and of Students failing a quorum**

A. McInerney explained the procedure for ratifying the amendments (see September 2009 minutes). Amendments passed by unanimous voice vote (over 39 Senate members present).

**7. Appointment of Senate Parliamentarian**

A. McInerney explained that the Senate Chairperson appoints the Parliamentarian. After a unanimous voice vote of confidence in the candidate, L. Brenner was appointed Parliamentarian.
