- C. Language 15 (Academic Affairs/ Modern Language)  
It was moved that there be a change in credit hours to 4 rec-3 credits instead of 4 rec-4 crs. for Language 15. (See attachment 5)

- D and E. Changes in prerequisites for AVT 10, AVT 11, AVT 12, AVT 13, AVT 23 and revised pattern sheets- options A and B (Library)
