B. Radio Broadcasting, Department of Communication Arts and Sciences

Radio Broadcasting 3 rec 3 cr
 A theory and practical course in the art and profession of radio broadcasting. Students will be exposed to the techniques of radio broadcasting and they will explore the various careers available in the field. A study of communication theory for broadcasting, programming, script preparation, news and sports analysis, performance skills, and responsibility of persons in the mass media field. Written oral and practicum assignments required. Final written examination.

Prerequisites: CMS 11 and CMS 10 or 12.

Permission of instructor can be substituted for CMS 10 or 12.

Continued study and application of the principles of organization and rhetoric; expository writing based on non-fiction readings; development of critical thinking. Research paper required. Prerequisite: English 13.
