- B. The State Education Department has given final approval to the Radiologic Technology Curriculum and the Certificate in Licensed Practical Nursing.
- C. A letter of intent has been forwarded from the College to the Central Office in connection with the planned curriculum in Automotive Technology.


V. Elections
