II. The meeting was called to order at 2:25 p.m. by Prof. Ryan.

III. The minutes of Nov. 26th were corrected as follows:

B. Goodwin should be listed as a Student Government representative,
not as a Curriculum Coordinator.

The corrected minutes were then approved.

IV. Correspondence, Reports, Announcements

A. The Office of the Dean of Academic Affairs announced that OCD 01 is a
required course that must appear in every curriculum pattern sheet.

B. Prof. Ryan noted an error in the Committee's agenda: item F, regarding
proposed new course of Dept. of Physics, "Senior NMT Project" and change
in NMT 81, action is possible.

C. Prof. Ryan announced that few curriculum coordinators had responded to
the Committee's request for response to recommendations regarding
curriculum pattern sheets for the A.A.S. degree.

- D. Prof. Lieblich noted that some curricula are only accepting Math 21 as a curriculum requirement. He wishes to have the requirement permit any math course in the 20 series courses. Prof. Ryan stated that this was a matter to be negotiated with each curriculum advisor.

V. Old Business

- A. The following agenda items are postponed:
Item A. proposed new curriculum: Allied Truck and Bus Technology
Item B. proposed new curriculum: Allied Aviation Technology
Item C. proposed new curriculum: Allied Transportation Program
- B. Prof. Blot responded to questions regarding the Department of Special Education Services' proposed change in EDU 45, from "Tutoring Techniques" to "Mentoring Techniques." The proposal returns to the next meeting's agenda, with action possible.
- C. The experimental new course, MTH 29, "Pre-calculus for Business Students," 4 rec., 4 cr., was approved by a vote of 15-0-1.
- D. (To have been considered under new business, Prof. Ryan suggested this agenda change; there was no objection.) The Department of Music and Art, represented by Prof. Canton, proposed a new course, "Creative Computer Music," 2 rec., 1 lab., 2 cr. A guest, Mr. Peter Goldbeck, made a statement concerning the need for the course. Questions were received and the proposal returns to the next meeting's agenda, with no action possible.
- E. Prof. Lal moved the acceptance of the Department of Physics' proposal for change of the existing curriculum, Nuclear Medicine Technology, to include the new course, "Senior NMT Project," 0 rec., 1 cr., and change of the existing course, NMT 81, "Orientation to Nuclear Medicine," from 1 lec., 1 cr. to 2 lec., 2 cr. The motion was seconded. Action was postponed until the next meeting.
- F. Prof. Moghaddasi of the Department of Electrical Technology responded to questions regarding the proposed changes in the Electrical Technology curriculum: new course, "Computer Programming for Engineering Technology," 1 lec., 2 lab., 2 cr. and changes in ELC 35, "Communications Electronics" (prereq. change); ELC 81, "High Frequency Electronics" (description and co-req. change); ELC 98, "Computer Circuits" (description and prereq. change). The proposal returns to the next meeting's agenda, with action possible.

- G. Prof. Suarez responded to questions regarding the Department of Business' proposed new curriculum, Health Care Management, A.S. The proposal returns to the next meeting's agenda, with action possible.

VI. New Business

- A. The Department of Biology proposed two new courses: Biomedical Research, I and II, Symposia, 3 cr. each. Questions were received and the proposal returns to the next agenda, with no action possible.
- B. Prof. Resto requested that the Dean of Academic Affairs' announcement that OCD 01 should appear on all pattern sheets be taken up for discussion by the committee.
