- D. Prof. Strieby discussed the reasons for two new courses, *Introduction to Case Management* and *Habituation and Addiction and Its Prevention*, proposed for the Social Sciences Department. Questions were posed for that department.
- E. Prof. Fuld explained the reasons for proposed changes in BIO 50 (Biology and the Law). Questions were raised for that department.
