1. Dr. Ryan called the meeting to order at 2:50 p.m.
2. A. The minutes of Feb. 23, 1993 and March 9, 1993 were approved unanimously.

  - A. The December 8, 1992 minutes of the Subcommittee on Continuing Education are attached (p. 123).
  - B. The Dept. of English announced its discontinuance of English 10 (Attached, p. 124).
  - C. The Dept. of Social Sciences deferred to the March 30 meeting consideration of the proposed Introduction to Case Management.
4. ORDER OF THE DAY  
Without objection, the order of the agenda was changed so that BIO 50 could be considered first.
5. OLD BUSINESS
  - A. **BIO 50--Revision of Existing Course.**  
Prof. Fuld noted its transferability was approved by John Jay (written) and Lehman (orally).  
**The revised course was approved 15-0-0.** (Attached, p. 125)
  - B. **Finalization of procedures for implementation of the first phases of CPI:** The chair had requested statements from program coordinators on the impact of CPI. There were discussion and suggested emendations of submissions from audio-visual, business, paralegal, math option, computer science, liberal arts, and social sciences. An omnibus

motion will be presented when discussion of all curricular statements has finished.

**C. Revision of two options in Paralegal Studies: Lay Advocate and Lawyer's Assistant.**

Both revised options were approved 17-0-0. (Attached, pp. 126-128)

**D. Revision of Electrical Technology Curriculum.**

The revised curriculum with attendant new courses was approved 17-0-0. (Attached, pp. 129-133)

**E. New Course: Tapping the Multicultural Roots of Success (Experimental).**

The course was endorsed 9-8-0. (Attached, p. 134)

**F. Revised Curriculum Option: Health Care Management.**

The option was approved 16-0-1. (Attached, pp. 135-136)
