2. Dr. Ryan called the meeting to order at 2:45 P.M.

3. The minutes of March 30, 1993 were corrected to include the attendance of Prof. A. Resto, and passed unanimously as corrected.

4. Correspondence, Reports, Announcements

A. Dr. Ryan reminded committee members that the Curriculum Committee's Subcommittee on Course Evaluation expects by April 30, 1993 departmental reviews of courses evaluated previously, all new or revised courses offered since Fall 1988, and all courses reactivated since Fall 1988 and not taught for five years or longer. Prof. Angel Resto volunteered to serve on this subcommittee.

B. Prof. Bernard Witlieb presented the report from the Curriculum Committee Subcommittee on Continuing Education. This subcommittee voted not to approve the proposal "City Works." The Curriculum Committee unanimously passed a motion to place Resolutions #1 and #2 concerning the "City Works" proposal on the agenda for the next meeting. Dr. Ryan will invite Dean Thomas and the director of the program to meet with the Curriculum Committee to provide more information, including documentation, about the program.

5. Old Business

- A. The committee reviewed Dr. Ryan's document, Final Guidelines for the Implementation of CPI (First Phase) at Bronx Community College, Fall 1993. Committee members voted unanimously to accept this document as revised, and thanked Dr. Ryan for his efforts.
- B. Prof. Reid Strieby from the Social Sciences Department answered questions concerning a new course, Introduction to Case Management and Crisis Intervention for Child Care Workers, as well as the proposed Child Care Worker Certificate Program, sponsored jointly by Bronx Community College and Lehman College. He was asked to return to the committee with more course descriptions and explanations.
- C. Prof. Mitchell Wenzel provided additional documentation and answered questions concerning the proposed change in status from experimental to permanent of the Water Aerobics course.

6. Adjournment

The meeting adjourned at 4:20 P.M.
