2. Dr. Ryan called the meeting to order at 2:45 P.M.

3. The minutes of April 13, 1993 were approved unanimously

4. Correspondence, Reports, Announcements

A. Dr. Ryan announced that he had received a document from Dean Berkman regarding the form of CPI. Dr. Ryan summarized the gist of this communication.

B. Curriculum coordinators were asked to indicate how CPI will be accommodated, when they amend their flowcharts.

5. Old Business

A. Prof. Reid Strieby presented documentation and answered questions concerning the proposed new Child Care Worker certificate program and attendant new courses. An amendment to add a communications course to this curriculum was defeated: 3-12-0. A proposal to approve both the program and new courses as a package was rejected: 8-7-1. Dean Fuller asked for a reconsideration of this vote. A motion to do so was made and passed: 10-5. Subsequently, each proposed experimental course and the program itself were voted upon in seriatim. Introduction to Case Management was approved: 11-2-2. Issues in Human Service for Child Care Workers was approved: 11-3-1. Community Health Resources for Child Care

workers passed: 8-6-1. Finally, the new Child Care Worker certificate program was approved: 9-6-0

- B. The proposed change in status from experimental to permanent of the Water Aerobics course was approved unanimously: 16-0-0.

5. New Business

- A. Ms Ju Won Choi, director of City Works, visited the meeting to discuss this program and answer questions. In an advisory vote to the Continuing Education Department, the committee voted to accept Resolution #1 from the Curriculum Committee Sub-Committee on Continuing Education, which met on March 30, 1993. Resolution #1 reads, "The Curriculum Committee Sub-Committee on Continuing Education does not approve the proposal, City Works." The vote to accept this resolution was 13-3-0.
- B. Prof. Henry Frisz reported on the progress of transferring the automotive program from New York City Technical College to BCC. The committee gave him feedback and endorsed the concept of the program by viva voce vote
- C. Dean Fuller, reporting from the Subcommittee on Course Evaluation, announced that this committee had not heard from all the departments, and therefore its written report would probably be forthcoming in the fall.
