4. Correspondence, Reports, Announcements
- A. Dean Polowczyk received a letter from Dean Berkman endorsing the direction of BCC's plans for CPI implementation.
- B. Byron Connell from the New York State Education Department wrote a note to Chancellor Ann Reynolds confirming receipt of requests for curricular changes in AS, Business Administration; AS, Paralegal Studies; and AAS, Electrical Technology at BCC. These requests are being reviewed.
