- 1. Chairman James Ryan called the meeting to order at 2:46 P.M.
- 11. The minutes of April 23, 1996 were approved unanimously with the following correction. Page 162, line 1 - Insert **merged and/or**, line now reads "The following departments and programs will be merged and/or consolidated."

111. CORRESPONDENCE, REPORTS, ANNOUNCEMENTS:

- A. The Chairman reported that the Professional Staff Congress suit against the Chancellor and the Board of Trustees' actions which declared financial exigency and mandated reduction of all Curricula credit requirements was overturned by the decision of Judge Shlessinger. The Board of Trustees will have one year to appeal this decision.
- B. A memo dated May 2 from Vice Chancellor Freedlander to President Corbie indicating that all Curricula revisions completed at Bronx Community College are in good order and will appear in the May Chancellor's report for action.
- C. A letter dated April 25 from Vice Chancellor Freelander to Dean Polowczyk concerning the requirements to be included in the Letter of Intent for the AS degree in Chemistry.
- D. A letter dated April 26 from Vice Chancellor Freelander to Dean Polowczyk indicating that no waiver was required for the proposed "Human Services Curriculum" revision. The required credits for the AA degree fall within the Board requirements.
- E. Charlotte Honda reviewed the requirements and format for the "Letter of Intent" for new curricula and requested that all departments follow the same guidelines.

Cardiac Ultrasound (2 lec., 4 lab - 160 clinical hours, 4 cr.)

Course Catalog Description

Introduction to Cardiac Ultrasound. Topics include: Review of anatomy/physiology, physics of ultrasound, ultrasound instrumentation, emergency medical procedures, doppler and transesophageal echocardiology. The clinical rotation will be at Montefiore Medical Center. During the clinical phase each student will participate in approximately 150 procedures. Students completing this course will receive a certificate from Montefiore Medical Center. Prerequisites: Permission of NMT Program Director.

- B. After extended discussion, the committee endorsed, by consensus, with no dissent, an expression of satisfaction with the recent decision of the court, which raised questions concerning the appropriateness of the Board of Trustees' mandate that credits for AA, AS, and AAS degrees be reduced to 60. The committee affirms opposition to mandated reductions because it believes they are, on balance, educationally unsound and not in the best interests of our students. The committee hopes, if the court decision is upheld and the mandate to reduce credits is rescinded, to revisit effected curricula and where appropriate, strengthen them through the addition of college credits.
- C. Congratulatory
The Chairman recommended that the committee members congratulate themselves for the extraordinary effort made during the the past academic year in reviewing and revising all curricula at the college necessitated by the Board of Trustees' mandate.
