E. Student Activities

F. Instruction and Professional Development

Professor Pomerantz replied to suggestions of the Senate (in a 13 November 1986 memorandum to Prof. Tyson)



concerning revision of the questionnaire for student evaluation of the Faculty. The new questionnaire will include an introductory statement to the questions, and there will be changes in the meaning of the scores. The former questionnaire will continue in use this semester, and the new questionnaire will be used in the fall of 1987. He also reported progress in the development of future workshops.

2. Report From the University Faculty Senate

No report. Professor Tyson announced that the UFS has responded to his memo, which suggested improvements in the intelligibility of its minutes, by affirming the status quo.

4. Title III Report

Doctor Forman reported on the availability of funds for improvement of existing programs, and for the development of new curricula.

Doctor DeAcetis reported on developments in the teaching of Physics. This program encourages the spirit on inquiry through the interaction among students, and with computers for verification of their work. The program involves the use of a study guide and individualized assignments. Individualized examinations are planned.

Discussion was held on the process of nomination and selection of its membership. To secure the widest participation of volunteers to form a slate of nominees for election to this committee, it was suggested that Prof. Tyson write to all Senators and department chairpersons.



B. BCC/Cuny Acronyms

Professor Tyson reported that Doctor Squitieri's work on acronyms has been delivered to the Dean of Academic Affairs as the next step toward publication.

C. Nominations for At-large Senator Vacancy

Doctor Joseph O'Sullivan was nominated; the Executive Committee will act on the nomination.

7. Announcements:

A. Dean Polowczyk

The Dean reminded the Senate of the dates of the Thanksgiving holidays. He announced the Dean's List Reception to be held on 4 December. He described improvements in the guide for early registration (8-19 December). Once early registrations are ratified by final grades, students will make their payments on 20-21 January 1987. The schedule for final examinations becomes available on 24 November. He also announced that preparations are under way to occupy Silver Hall by 1 February 1987.
