- II The minutes of the previous meeting were approved unanimously.
- III Correspondence, reports and announcements:
 - A. Chairperson Clampman welcomed Professor Ryan, noting his distinguished service to the committee, in honor of which refreshments were served.
 - B. Chairperson Clampman Vice announced the receipt from Vice President Keizs of a memorandum from Dr. Stephen Greenfield of Director of Academic Advisement to Dean Posner requesting the listing of those courses having an advanced writing component.

Professor Berger of the Department of Social Sciences and Professor Lopez-Marron answered questions asked by the committee regarding the proposed changes in the catalog description of the foreign language requirement in the Human Services AA curriculum. No action possible. This item was withdrawn from the agenda.

D. Professors Cukras and D'Alessio of the Department of Education and Reading answered questions asked by the committee on three proposed Certificate Programs:

1. Early Childhood Education Assistant Certificate Program.
2. Bilingual Early Childhood Certificate Program.
