1. **Meeting called to order** at 2:25PM by R. Ben-Nun.
2. **Approval of December 5, 2016 SEC agenda:** Approved by unanimous voice vote.
3. **Approval of October 24, 2016 and November 14, 2016 SEC Minutes:** Minutes of October 24, 2016 were approved by unanimous voice vote. Minutes of November 14, 2016 were approved with an amendment by unanimous voice vote.

Ellis stated that the retroactive payments were largely calculated by the university's central office and that it would be difficult for the college to give a detailed accounting. D. Gonsher expressed her concern that employees who did additional work, such as adjuncting or summer teaching, would not be able to ensure they received correct payment. R. Ben-Nun seconded D. Gonsher's concern. T. Isekenegbe asked K. Ellis to write an email to G. Waters, Vice Chancellor for Human Resources, requesting that detailed information be provided to recipients of retroactive pay. S. Utakis said that the union was unable to double-check the university's work because it did not have access to the relevant information.
8. **Approval of December 8, 2016 Senate agenda:** Additional time was provided for the budget presentation. R. Ben-Nun said that if the committee on Instruction and Professional Development did not have an action item, he would only give it five minutes. The agenda was approved with edits by unanimous voice vote.
